UPDATE ON WATERCRAFT TOPICS

1. The following people have notified the City that they will not have their mooring/boat in the water at the time of the inspection:
 - A) Anthony & Molly Rutz #18 - Windmill Maria is currently making and will be installing the mooring anchor.
 - B) Gary Thole #27 – Boat motor is in for repairs.
2. A) A letter was sent to Mike Robinson on 6-2-2025 with the offer of buoy permit #13. See attached copy. As of noon today we have not heard from him and have not received the completed permit application form or payment. I will follow up with an email to him after your meeting. Please let me know how long I should give him before I offer the permit to the next person on the wait list.
 - B) Please discuss the placement of this buoy, knowing that his sailboat has a deep keel.
3. Confirm a date for Inspections (typically on or soon after June 15th.)
4. Discuss letter (attached) sent to Dr. Maria O'Connell on 6-2-2025 regarding a large amount (a cord) of firewood placed on beach along with kayaks that are not listed on her permit application this year.
 - A) My letter gives her 10 days to remove the firewood (ie June 12th).Here is the ordinance referring to open fires in the city. I cannot find anything that talks about fires on the beach!!

§ 93.21 OPEN BURNING.

(A) It shall be unlawful for any person to start or allow to burn, any open fire on any property within the city without first having obtained a "burn permit" from the Lower St. Croix Valley Fire Protection District, except for supervised recreational or cooking fires within approved fire rings, pits, or barbecue grills.

(B) RECREATIONAL FIRES are defined as having no more than three feet in diameter at their bases, with flame height not exceeding three feet, and fueled only by natural wood with logs three inches in diameter or larger. Fires fueled by other materials, including but not limited to

treated or painted wood, plastic, rubber, leaves, grass, trimmings, or any garden or yard vegetation, regardless of size, are not RECREATIONAL FIRES.

(C) Recreational fires shall be:

- (1) Constantly attended by a person until the fire is totally extinguished.*
- (2) Conducted at least 15 feet from a structure or combustible material.*
- (3) Take place on the owner's property and be a minimum of five feet from all property lines.*

(D) A means of extinguishing the fire quickly must be readily available for immediate use.

Acceptable on-site fire extinguishing means to include at least one of the following:

- (1) Portable fire extinguisher with a minimum 4-A rating.*
- (2) A shovel with readily available dirt or sand.*
- (3) An operational garden hose attached to a water source, or a water barrel.*

(E) When a burning ban has been issued by the Commissioner of the Minnesota Department of Natural Resources or other authorized unit of government, the City may suspend all recreational fires for the duration of the ban.

(F) A fire must be extinguished if it is smoldering or becomes a nuisance (e.g., annoys, cause injuries, or endangers the health, safety, comfort, or repose of the public,) to others or if not under supervision.

(G) Recreational fires on property of multi-family residences or on rental property are the responsibility of the property owner, its management, or association, as it maybe so organized. Residents thereof must adhere to the provisions of this section of the city code.

(H) Failure to comply with the provisions of this section of the city code constitutes a public nuisance, and is subject to an additional fine equal to the costs of Fire District actions needed to ensure compliance with them and to safeguard life and property.

Penalty, see § 10.99

The city has been made aware that you have a large pile of firewood on the beach along with a couple of kayaks.

Firstly, remove the wood pile from the Shoreland Park. Please have this removed within the next 10 days or the city will have it removed and you will be charged for the cost of removal and disposal. As of last week the river levels have scattered the wood along the City Park beach, and out into the river, potentially creating a hazardous situation for boaters.

Secondly, you have two kayaks that do not have City Permits. Please refer to your Watercraft Permit application (see attached) that does not show that you applied for any shoreboats. Come into City Hall to complete the application and pay the fee (\$25 per kayak) within 10 days.
